"On behalf of the State of Virginia I have the honor of inviting you to attend the Fifth Conference on State and Local Taxation, to be held in Richmond, September 5-8, 1911, under the auspices of the International Tax Association, and, also, of inviting you to appoint three delegates and three alternates, who will attend and represent your State in this Conference.

"In order to secure the best possible service from the delegates you appoint, you are especially requested to instruct them to submit an official report to you, in proper form to be transmitted to the Legislature for its information, upon the proceedings and conclusions of this Conference.

"The inclosed bulletin gives the names and membership of ten committees, which will submit reports to this Conference.
